The purpose of this letter is to confirm that W [redacted] A. ("W [redacted]") has conditionally approved your request for a short sale of the above-referenced Property. This approval is valid only for a sale in connection with the above-reference Buyer(s) and for a sale closing by September 22, 2011, if not closed by this date you will need to get a new approval letter from W [redacted]

This approval of a short sale with respect to the above-referenced Property is conditioned on your compliance with all Short Sale Guidelines, which have previously been provided. [redacted] is entitled to all proceeds from the sale except those necessary to pay off any senior liens and customary seller's closing costs.
